Dear Eric Soskin,

We the undersigned urge the Office of Inspector General to investigate whether officials at the Department of Transportation engaged in misconduct and abuse, breached ethics rules and agency standards of conduct, and violated federal law when they coordinated with lobbyists from the trucking industry to suppress taxpayer-financed research on improving public safety in underride crashes with large commercial freight trucks.

Investigative reporting by PBS Frontline and ProPublica revealed that in 2019 and 2020, officials at the Department of Transportation (DOT), at the direction of lobbyists from the trucking industry, censored any mention of the word "regulation" and struck whole sections of a draft government report that assessed technology designed to protect pedestrians, bicyclists, and other vulnerable road users from death and horrific injuries in collisions with commercial freight trucks. The investigation found,

"ATA lobbyists were allowed to review a draft of the report before publication. After the input, researchers were told to remove any use of the word 'regulation'. The final report didn't reflect the researchers' findings, that the [side]guards would save enough lives to justify their cost."

Based on emails, communications and an industry-edited draft, the journalists said, "It seems like every part [of the draft report] is contested by industry."<sup>1</sup>

These findings raise very serious concerns. If true, they could constitute misconduct, conflict of interest, unethical conduct, and potentially public corruption. At a minimum, they would constitute an abuse of the agency's mission. In 1999, known as the "second founding" of the DOT, Congress required that the Department pursue "safety as the highest priority, recognizing

the clear intent, encouragement, and dedication of Congress to the furtherance of the highest degree of safety in motor carrier transportation."<sup>2</sup>

Underride crashes are devastating and horrifically violent. They are also preventable. Requirements for side underride guards have been under consideration at DOT since 1969, yet next to no progress has occurred since that time. This has come at an incredible cost. The National Highway Traffic Safety Administration (NHTSA) reports that in 2021 over 5,700 lost their lives in truck crashes and another 155,000 were injured. <sup>3</sup> These losses are unacceptable, and side underride guards can help prevent much of this needless loss of life. The DOT Office of Inspector General should treat this issue with the utmost urgency and conduct a robust investigation as soon as possible.
