PETITION under the Administrative Procedure Act

Dear Secretary Buttigieg:

In accordance with Administrative Procedure Act (APA), I hereby petition the U.S. Department of Transportation (USDOT) and the National Highway Traffic Safety Administration (NHTSA) to promptly issue, amend, modify, or repeal the relevant regulations or guidance documents (49 CER 5.3: 5 U.S.C. 8553(e)) in order to:

Update FARS User's and Coding Manuals, the Model Minimum Uniform Crash Criteria, and other guidance documents to provide a standardized definition of underride and override crashes

Modify the existing FARS underride/override data element to differentiate and collect data on rear underride, side underride, and front override crashes



Require an Underride/Override "Checkbox" on State Police Crash Report Forms when States upgrade and standardize their electronically reported State crash data systems
